



## **PRIVACY POLICY**

The data controller of this website is Malta Paralympic Committee ('MPC') whose office is situated at Malta Council for the Voluntary Sector Volunteer Centre, 181, Melita Street, Valletta, VLT 1129, Malta.

This privacy policy describes the MPC's current policies and practices with regard to personal data which you provide to MPC and sets out how MPC uses and protects any information that you provide when you use MPC's website (hereinafter the "MPC's website"). This privacy policy is independent from MPC's offline personal data collection practices.

The term "personal data" refers to personally identifiable information about you, such as your name, birth date, e-mail address or mailing address, and any other information that is identified with you personally.

### **Notification of changes to this policy**

MPC is continually improving and adding new functionality and features to its websites and improving and adding to our existing products, services, and programs. Because of these ongoing changes, changes in the law, and the changing nature of technology, MPC's data practices will change from time to time. If and when our data practices change, MPC will post the changes on our websites to notify you of the changes. We encourage you to check this page frequently.

### **Personal data collected**

This section gives you an idea of the information that MPC may collect about you.

MPC may collect information that you voluntarily give us when you use our sites. For example, you may use this site to contact MPC with questions and comments. When you fill out a form on our website, you may provide your name and other contact information, including your or your company's name, your e-mail address, and your mailing address or the mailing address of your company or other personal information.

In addition to the information you provide when you use our website, MPC may also use technology to collect anonymous information about the use of our websites. For example, we may use technology to track how many visitors access our websites, the date and time of their visit, the length of their stay, and which pages they view. We may also use technology to determine which web browsers our visitors use and the address from which they accessed our sites (for example, if they connected to a MPC website by clicking on one of our banner ads). This technology does not identify you personally. It simply enables us to compile statistics about our visitors and their use of our sites. MPC use this anonymous data and share it with third parties to improve the content and functionality of our websites, to better understand our customers and markets, and to improve our products and services.

Our website also uses only session cookies which are erased when the user closes the Web browser. Cookies are small pieces of data that the site transfers to the user's computer hard drive when the user visits the website. The session cookie is stored in temporary memory and is not retained after the browser is closed. Session cookies do not collect information from the user's computer. They will typically store information in the form of a session identification that does not personally identify the user.



## **Use of personal data**

When you provide your personal data on the website, MPC uses that personal data to answer the query you will have posted through the site. MPC may transfer personal data to affiliates, including web hosting provider and other data processors who shall strictly process your data in terms of MPC's instructions. Personal information is collected to help us improve the content and functionalities of our website, to better understand our clients and the markets in which they operate, and to improve our products and services. MPC and our affiliates may use this information to contact you in the future to tell you about products or services we believe will be of interest to you. If we do so, each communication we send you will contain instructions permitting you to "opt-out" of receiving future communications.

Similarly, we may provide "subscription" e-mail services, either directly or through affiliates, which enable you to receive current news about MPC and its business. For all such services, we will provide an opportunity to "opt-out" of, or cancel, the subscription.

## **Requirements and criteria for processing**

As a data controller, MPC ensures that it shall process your personal data in accordance with its obligations in terms of the applicable data protection legislation and subsidiary legislation thereto.

## **Disclosure of your personal data**

MPC may share some or all of the personal data collected through this website with our affiliates in Malta and overseas, who use this data in accordance with this Privacy Policy. Both MPC and our affiliates may share personal data collected through its websites with third-party vendors in Malta and overseas who act for or on behalf of MPC or our affiliates (for example, companies that provide support services to us, including data processing services, or that help us market our products and services). These companies may need information about you in order to perform their functions. These companies are not authorized to use the information we share with them for any other purpose. In addition, there may be some other, limited circumstances in which MPC or our affiliates may share or transfer the personal data in our databases, for example, to comply with a legal requirement, for the administration of justice, to protect your vital interests, or in the event of a corporate sale, merger, reorganization, dissolution, or similar event.

## **Link to other sites**

This privacy policy applies only to MPC's website. Please take a moment to review the privacy policy posted on that site to learn what personal data may be collected through that site and how it is processed.

MPC's websites may contain hyperlinks to websites that are not operated by MPC or one of our affiliates. These hyperlinks are provided for your reference and convenience only and do not imply any endorsement of the activities of these third-party websites or any association with their operators. When connecting to such other websites you will no longer be subject to this policy but to the privacy policy of the new site. MPC does not control these websites and is not responsible for their data practices. ## **Rectification, deletion etc.**

MPC shall at your request, immediately rectify, block or erase your personal data. MPC shall notify any third party or affiliate to whom the data has been disclosed about the measures undertaken as aforesaid. Provided that no such notification needs be provided if it is shown to be impossible or it will involve a disproportionate effort.

## **Subject access policy**

As a data subject, you may exercise your right to access the data held about you by MPC, by submitting your request in writing to us. Provided that such requests are made at reasonable intervals.

MPC shall provide to the data subject written information in an intelligible form about:

- (a) actual information about the data subject which is processed;
- (b) where this information has been collected;
- (c) the purpose of the processing;
- (d) to which recipients or categories of recipients the information is disclosed; and
- (e) knowledge of the logic involved in any automatic processing of data concerning the data subject.

Although all reasonable efforts will be made to keep your information updated, you are kindly requested to inform us of any change referring to the personal data held by MPC. In any case if you consider that certain information about you is inaccurate, you may request rectification of such data.

## **Governing law**

This privacy policy is governed by and construed in accordance with the laws of the Republic of Malta and relevant EU legislation.
